## TOWN OF EATON LOCAL LAW NO. 1 OF 2025

("A Local Law Amending Article 1 of Chapter 170 of the Town of Eaton Code")

Councilmember Golley introduced proposed Local Law No. 1-2025, relating to Article 1, "Senior

Citizen Exemption", of Chapter 170, "Taxation" of the Town of Eaton Code, which provides a tax exemption

on real property which is owned by certain persons with limited income who are 65 years of age or older, and

made the following motion, which was seconded by Councilmember Hilts:

**WHEREAS**, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Eaton, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, the adoption of said Local Law is an unlisted action for purposes of environmental review under SEQRA; and

**WHEREAS**, the Town Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, said EAF has been prepared and has been reviewed by the Town Board; and

**WHEREAS**, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

#### NOW, THEREFORE, BE IT

**RESOLVED AND DETERMINED** that the Town Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQRA; and it is further;

**RESOLVED AND DETERMINED** that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. 1-2025 at the Town Hall located at 35 Cedar Street, Morrisville, New York 13408 on January 14, 2025, at 6:10 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.
