The proposed zoning use change for the property in question from RD2 (Residential District No. 2) to ARC (Agricultural/Residential/Commercial) is not inconsistent with current uses of the adjacent property to the south and five parcels on the west side of Route 12B. This past commercial development has already effectively separated the proposed property from the waterbody (Woodman Pond) that was the basis for the original RD2 zoning.
