A variance of 16' is granted for the front (road side) of the property. The building, including overhang, shall come no closer than 34' from this property line.

Vice-Chairperson Page made a motion for a negative SEQR. Board member Groves seconded. All ayes.

After review and discussion, Vice-Chairperson Page made a motion to approve the variance request as presented and with the following conditions:

A variance of 35' is granted for the rear (lake) side of the property. The deck, including stairs, shall come no closer than 15' from the water property line.

A variance of 12' is granted for the left side property line. The deck shall come no closer than 13' from this property line.

Board member Groves seconded. All ayes.

#### Cope

Vice-Chairperson Page made a motion for a negative SEQR. Board member Groves seconded. All ayes.

After review and discussion, Vice-Chairperson Page made a motion to approve the variance request as presented and with the following condition:

A variance of 15' is granted for the Westland Drive road side. The building, including overhang, shall come no closer than 35' from the edge of the road.

Board member Groves seconded. All ayes.

Board member Groves made a motion to adjourn the meeting, seconded by Vice-Chairperson Page. The meeting was adjourned at 7:42 p.m.
